# Southport Summer Market Guidelines

## ARTS & CRAFTS

Homemade arts & crafts only – imports or flea market/yard sale type items are not allowed.

All NEW Arts & Crafts applications are required to submit two (2) pictures of each item for pre-approval by the Southport Summer Market Committee.

Same-type crafts will be limited to a maximum of five (5) vendors. Exceptions must be approved the Market Committee.

## HOMEMADE FOOD ITEMS

Homemade food vendors are required to obtain a

“home inspection” from the NC Department of Agriculture & Consumer Services. A copy of your Home inspection must be submitted with your application. For more information call NCDACS at 919.733.7366 or Marion Martin 910.620.2308.

DSI reserves the right to refuse any arts, craft or

food products that do not meet the Market requirements.

## SPACE ASSIGNMENTS

Space assignments will be made on the first day of the market season. Repeating vendors will keep their same spaces.

Each successive week, daily vendors must arrive or contact Marion Martin for the late arrival no later than 8:30 am or the space may be reassigned to another vendor for the day.



Vendors may submit their applications to be reviewed.

Vendor selection will be made by the Market Committee.
